Encryption

PROBLEM

We work with sensitive, private customer information that for legal reasons needs to be encrypted, but we still need to use and share it flexibly within our company.

SOLUTION

ESET's encryption solution is easy to deploy and manage, and is scalable according to your needs.

Meets standards for sensitive and private data handling (e.g. ICO, SOX, EU DPD...), but still allows that data to be shared among authorized users.

Effective Reporting

PROBLEM

RIP & Replace

Automation by Agent

PROBLEM

We spend a lot of time on repetitive day-to-day tasks. And our mobile workforce isn't always connected to the corporate network - so how can we control security?

SOLUTION

Automation by Agent: All tasks are run by an independent agent directly on the endpoint, even without connectivity to ESET Remote Administrator. Results (logs) are then synchronized upon connection.

Virtualization Support

PROBLEM

We are virtualizing our network and are afraid of AV storms and the overall performance of anti-malware solutions on virtual machines (VMs).

Virtualization Support: ESET Shared Local Cache prevents scanning of the same files on all VMs. Moreover, an agentless solution is available for platforms supporting such an approach.

PROBLEM

ESET Remote Administrator running on Linux
